



REVOLUTIONARY WAR 10 AMERICAN MILITARY LODGES

- "St. John's Regimental" was granted a warrant by the Provincial Grand Lodge of New York, in July, 1775.
- "American Union" in the Connecticut Line, though of later date, was the first Lodge organized in the Continental Army.
- "Washington Lodge", in the Massachusetts Line—at whose meetings the Commander-in-Chief was a frequent visitor—was constituted at West Point, in 1779.
- "Army Lodge, No. 27", in the Maryland Line, received a warrant from Pennsylvania, in 1780. The first Master was General Mordecai Gist, and the Wardens, Colonel (afterwards General) Otlio Williams and Major Archibald Anderson.
- No records of the American Field Lodges of the Revolution have been preserved, except a portion of the minutes of "American Union," and some returns of the "Washington Lodge." The latter merely inform us that in 1782, two hundred and fifty names had been borne on the roll of the Lodge.



MILITARY LODGES IN THE CIVIL WAR



The House Undivided states that in an effort to meet the social and fraternal needs of the soldiers of the North and South there were not less than 244/251 "Traveling Military Lodges" operating during the War Between the States. Ninety-eight were Union Lodges and 153 were Confederate. Among the more active Grand Lodges were: Texas (50/33), Indiana (37/38), Mississippi /29 and Virginia (28/26). These states accounted for over half of the military lodges.

Alabama granted dispensations to 19 lodges. P 106

Arkansas granted dispensations to 16 lodges.




Halleck Military Lodge reported 145 initiated; 187 passed; 128 raised; nine rejected. In 1864 the lodge paid \$68 in dues and asked to have the dispensation continued, which was granted.

Brother William Vaughn is responsible for a statement that his father told him that General U. S. Grant had been elected to receive the degrees and arrangements had been made to confer all three the same night but shortly before the date set he received an order to go south to Vicksburg and never came back so the degrees were not conferred.



BATTLE OF SHILOH APR 6-7, 1862





After Sherman captured Savannah, the culmination of his march to the sea, he was ordered by Union Army general-inchief Lt. Gen. Ulysses S. Grant to embark his army on ships to reinforce the Army of the Potomac and the Army of the in Virginia.


Sherman had bigger things in mind. HJamese persuaded Grant that he should march north through the Carolinas instead, destroying everything of military value along the way, similar to his march to the sea through Georgia.

Sherman was particularly interested in targeting South Carolina, the first state to secede from the Union, for the effect it would have on Southern morale.



SHERMAN'S GENERALS CAROLINAS CAMPAIGN








MG JOHN SCHOFIELD ARMY OF THE OHIO



- Ordered to operate with Sherman in North Carolina, Schofield moved his corps by rail and sea to Fort Fisher, North Carolina, in 17 days, occupied Wilmington on February 22, 1865, fought the action at Kinston on March 10, and on March 23, joined Sherman at Goldsboro.


First Mayor of San Francisco

In December 1846, during the Mexican—American War, he was commissioned in the 2nd Pennsylvania Infantry, serving as lieutenant colonel. He led the regiment heroically at Chapultepec, and was wounded five times in the process.

Geary accepted Pierce's appointment as governor of the Kansas Territory on July 31, 1856

He distinguished himself in command during the Battle of Lookout Mountain, the entire Atlanta Campaign, Sherman's March to the Sea, and the Carolinas Campaign. He oversaw the surrender of Savannah, Georgia, and briefly served as the city's military governor, where he was breveted to major general. he was the commanding Union general at the fall of Savannah, Georgia. He placed Federal troops about the quarters of Solomon's Lodge No. 1 to save it from looting and damage.

After the war, Geary served two terms as the Republican governor of Pennsylvania, from 1867 to 1873

MG JOHN EUGENE SMITH 3rd Div, XV Corps

Smith was born in Bern, Switzerland, in 1816. His father had served under Napoleon Bonaparte and emigrated with his family to Philadelphia, Pennsylvania after the emperor's downfall.[1] In Philadelphia, Smith was educated to be a jeweler and 20 years later settled in Galena, Illinois, where he practiced his jewelry trade.[2] Smith was one of nine residents of Galena who would eventually become generals fighting for the Union during the Civil War. The other eight were: Augustus L. Chetlain, John O. Duer, Ulysses S. Grant, Jasper A. Maltby, Ely S. Parker, John A. Rawlins, William R. Rowley and John Corson Smith.

In December, 1863 Smith took command of the 3rd Division, XV Corps which he would command until the end of the war.[4] He saw action during the Atlanta Campaign, March to the Sea and the Carolinas Campaign.

In 1866 General Smith was mustered out of the volunteer service, but chose to stay in the regular army. He was appointed colonel of the 27th U.S. Infantry Regiment. He received a promotion to brigadier general in 1867 and a brevet promotion to major general in 1869.[

General Smith D. Atkins, of Illinois, relates that during the Atlanta campaign, when pressing the enemy, he saw a little white apron nailed to a cabin door, and riding up to the cabin he asked a woman he found there its significance, and was told that her husband was in Forest's Cavalry, which was then fighting; that her husband was a Freemason, and on leaving his home had said:

'There are many Freemasons in the Federal army, and if she would nail a white apron upon her door and let the Federals know she was the wife of a Freemason she would be protected.'"

It is unnecessary to say that she was unmolested.





ZEB V. VANCE MILITARY LODGE NO 2



40th Regiment Heavy Artillery, North Carolina State Troops was organized at Bald Head, Smith's Island, North Carolina, in November, 1863, from heavy artillery companies formed in 1861 and 1862.

In 1865 the unit was converted to infantry and assigned to Hagood's Brigade, Hoke's Division, Hardee's Corps.

It surrendered with the Army of Tennessee on April 26

MG JOHN CALVIN BROWN HARDEE'S CORPS

John Calvin Brown (January 6, 1827 – August 17, 1889) was a Confederate Army officer and an American politician and businessman. Although he originally opposed secession, Brown fought for the Confederacy during the American Civil War, eventually rising to the rank of major general.

He later served as the 19th Governor of Tennessee from 1871 to 1875, and was president of the state's 1870 constitutional convention, which wrote the current Tennessee State Constitution.

MG CARTER LITTLEPAGE STEVENSON JR. LEE'S CORPS

- Down to approximately 2,600 men, the depleted division participated in the Carolinas Campaign against William T. Sherman, making stands at Columbia; and Battle of Bentonville.
- For the second time in the war, Stevenson surrendered to the Federals when Joseph E. Johnston surrendered his army 26 April 1865 at Bennett Place, NC to W.T.Sherman.
- Stevenson again was paroled and sent home.






•Sherman's army commenced toward Columbia, South Carolina, in late January 1865.

•His 60,079 men were divided into three wings: the Army of the Tennessee, under Maj. Gen. Oliver O. Howard, the Army of the Ohio under Maj. Gen. John M. Schofield, and two corps, the XIV and XX, under Maj. Gen. Henry W. Slocum, which was later formally designated the Army of Georgia.


•Reinforcements arrived regularly during his march north, and by April 1 he commanded 88,948 men







Sherman's opponents on the Confederate side had considerably fewer men. His strength was recorded in mid-March at 9,513 and 15,188 by mid-April. The army was organized into three corps, commanded by Lt. Gen. William J. Hardee, Lt. Gen. Alexander P. Stewart, and Lt. Gen. Stephen D. Lee. Also in the Carolinas were cavalry forces under Lt. Gen. Wade Hampton and a small number in Wilmington under Gen. Braxton Bragg.



ICOLN 2ND INAGURAL ADDRESS 4 MARCH 1865

- At this second appearing to take the <u>oath</u> of the Presidential office there is less occasion for an extended address than there was at the first. Then a statement somewhat in detail of a course to be pursued seemed fitting and proper. Now, at the expiration of four years, during which public declarations have been constantly called forth on every point and phase of the great contest which still absorbs the attention and engrosses the energies of the nation, little that is new could be presented. The progress of our arms, upon which all else chiefly depends, is as well known to the public as to myself, and it is, I trust, reasonably satisfactory and encouraging to all. With high hope for the future, no prediction in regard to it is ventured...
- With malice toward none, with charity for all, with firmness in the right as God gives us to see the right, let us strive on to finish the work we are in, to bind up the nation's wounds, to care for him who shall have borne the battle and for his widow and his orphan, to do all which may achieve and cherish a just and lasting peace among ourselves and with all nations.




O Captain! my Captain! our fearful trip is done,

Fallen cold and dead.


